1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2022-23 was £8.82 per elector.

In 2022-23, the Council made payments totalling £ 200 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Llangedwyn Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Accounting Statement

In my opinion, the Accounting Statement has not been prepared in accordance with proper practice and does not properly present the Council's receipts and payments and financial position:

- The Council has excluded cheques that have been drawn but not presented from its annual return and therefore its total payments figure is understated by £641.60 and the corresponding entries in lines 7, 9 and 11 are overstated in the prior year comparative.
- The Council has excluded cheques that have been drawn but not presented from its annual return and therefore its total payments figure is understated by £134.00 and the corresponding entries in lines 7, 9 and 11 are overstated in the current financial year.

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 1: The Council has not prepared its accounts in accordance with proper practices.

- Assertion 3: The Council has not provided evidence that it submitted to the Independent Remuneration Panel for Wales (IRPW) a schedule of payments made to members. Although no payments were made the Council must submit a nil return to the IRPW confirming that no payments were made. In addition, the Council should seek to obtain written confirmation from individual members confirming that they do not want to accept their allowance

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Typographical error in Prior Year opening balances

The opening balances for the prior year comparative should be £7,843.

There are no further matters I wish to draw to the Council's attention.
