

**Minutes of Llangedwyn Community Council Meeting No 372
held on Tuesday 16th September 2025 at Llangedwyn Village Hall 7pm**

1. Apologies were received from Peter Keen, Maureen Wilde (Chair) and Paul Buckley (Dawn Cochrane as vice chair would chair the meeting)

2. Notification of pecuniary or other interests none declared

3. Minutes of Meeting No 371 held on Tuesday 15th July 2025.

4. Matters Arising (brief updates)

- a) Community Field (damaged fencing repairs update) **PB was not present this item c/f to the next meeting.**
- b) Parking Dol Emrys. **No progress so far.**
- c) Community Newsletter update (SF). **No current update SF and JM to meet to discuss and then poss get together with the clerk to see how to progress.**
- d) Strangeways and Vaughan Charity update (DC) **AD confirmed that he had now given DC address and details to the Charity Commission.**

The clerk had contacted PCC about the asset transfer programme and it was agreed to complete the playing field agreement and then look at the playground

6. Correspondence Recd/Business Correspondence circulated prior to the mtg.

Due to some councillors mail boxes being unable to accept the volume of e-mails being sent it was requested that in future the clerk send out forwarded e-mails in smaller batches poss weekly or bi weekly, this was agreed.

- Farm Estate Petition. **It was agreed that councillors should respond individually.**

Following discussion it was agreed to carry this item forward to the next meeting to give time for DC to check with MW to see if the Council already had a preferred solicitor and to check re the insurance

- 4. **The clerk reported that having spoken to some other community councils some of them were now having a summer meeting as they thought that 8-9 weeks gap was too long and items could get missed during that time, after a discussion it was agreed to leave things as they are at the moment with no LCC meeting in August.**
